

Sub-Processor List

CData Software, Inc. ("CData") uses certain sub-processors to assist it in providing the CData Services as described in the applicable agreement between CData and a customer ("Agreement"). Defined terms used herein shall have the same meaning as defined in the Agreement.

What is a Sub-Processor? A sub-processor is a third-party data processor engaged by CData, including CData affiliates and subsidiaries, who have or potentially will have access to or process personal data on behalf of a Customer. CData engages different types of sub-processors to perform various functions as explained in the tables below. CData refers to third parties that do not have access to or process personal data on behalf of a Customer, but who are otherwise used to provide the Services, as "subcontractors" and not "sub-processors."

Pipeline Data Sub-Processors

These are sub-processors who have access to production systems and application/connectors by virtue of the services they provide, to support CData in its performance of services for its customers. Use of these sub-processors may be varied by the contract terms in place between CData and a customer.
